WHEREAS the site keeps its natural characteristics (relief, vegetation, drainage...) and the expanded building won't obstruct views on elements of heritage or landscape interest from the public road;

WHEREAS alignment, orientation and the height of the base of the ground floor of the expanded building correspond to the mode of implementation generally observed in historical areas;

WHEREAS the height and the overall width of the expanded building are approximately the same as those of neighboring buildings that use the same classification;

WHEREAS all of the components on the front of the building, including the larger part, form a coherent whole and define an architectural style that is compatible with the age and the cultural period of the building as well as with those of the neighbouring buildings and typical buildings of the historic areas;

WHEREAS the roofs shape, slope and materials of the part attached are similar to those of the original part;

WHEREAS on facades of the building that are visible from a public or private road, type, position, shape, size, symmetry, measure and material of doors and windows of the attached part are similar to those of the original part;

WHEREAS on facades of the building that are visible from a public or private road, type of material, arrangement, texture and colors used for the cladding of the walls of the annexed part are similar in appearance or visually complement with the original part;

WHEREAS on facades of the building that are visible from a public or private road, doorframes, corner boards and other architectural details in prominence on the annexed part have a profile, a form and materials similar in appearance with those of the original part.

FOR THESE REASONS,
