WHEREAS:

The municipality has taken cognizance of the Guide relating to the terms and conditions for the payment of the government contribution under the Gas Tax and Quebec Contribution Program (TECQ) for the years 2019 to 2023;

The municipality must respect the terms and conditions of this guide that apply to it in order to receive the government contribution that was confirmed in a letter from the Minister of Municipal Affairs and Housing.

FOR THESE REASONS,

It is proposed by Councillor Ms. Tracy Sim and unanimously resolved that

The municipality commits itself to respect the terms of the guide that apply to it;

The municipality agrees to be solely responsible and to release the Government of Canada and the Government of Quebec as well as their ministers, senior officials, employees and agents from any liability for claims, demands, losses, damages and costs of any kind based on an injury to a person, the death of a person, damage to property or the loss of property attributable to a deliberate or negligent act arising directly or indirectly from investments made with financial assistance obtained under the TECQ 2019-2023 program;

The municipality approves the content and authorizes the sending to the Ministère des Affaires municipales et de l'Habitation of the attached work program version no. and all other documents required by the Ministère in order to receive the government contribution that was confirmed to it in a letter from the Minister of Municipal Affairs and Housing that the municipality is committed to achieving the minimum capital investment threshold imposed on it for all five years of the program;

The municipality undertakes to inform the Ministère des Affaires municipales et de l'Habitation of any changes that will be made to the work program approved by this resolution.

The Municipality hereby certifies that the attached work program version No. 4 contains true costs realized and reflects the cost estimates of the eligible work.

6.3 Purchase of land from Les Élevages JMS Inc.

RESOLUTION #22-06-96 MTQ 2022 INTERVENTION PERMIT **WHEREAS** the municipality must perform work in the right-of-way of roads for the maintenance of the Ministry of Transport

WHEREAS the municipality is responsible for the work for which it is the project manager

WHEREAS the municipality undertakes to respect the clauses of the intervention permits issued by the ministère des Transports

WHEREAS the municipality undertakes to restore the road infrastructures to their original state

WHEREAS it is necessary to obtain an intervention permit from the Ministry of Transport to intervene on the roads under the maintenance of the Ministry

WHEREAS the Municipality requests that the Ministry grant a road permit for all unplanned emergency work to be carried out for the period between January 1, 2022 and December 31, 2022

WHEREAS the Municipality requests that the Department not require a security deposit for all estimated costs of rehabilitation of the right-of-way elements not exceeding ten thousand dollars (\$10,000);

FOR THESE REASONS,

It is proposed by and unanimously resolved that the Town of Métis-sur-Mer requests from the ministère des Transports the required intervention permits for the work that it will have to carry out during the year 2022 in the right-of-way of the roads under the maintenance of the said Ministry and that to this end, authorize Mr. Frédéric Richard, Director of Public Works, to sign the said intervention permits

8.1 Request for a building permit pursuant to the PIIA at 494 Leggatt Road.

<u>RESOLUTION 22-06-97</u> BUILDING PERMIT APPLICATION UNDER THE PIIA AT 494 LEGGATT ROAD

This request for a building permit is for the expansion of the main building in the SPAIP zone.

CONSIDERING THAT the site retains, as much as possible, its natural features (relief, vegetation, drainage, etc.) and that the building extension will not obstruct views of elements of heritage or landscape interest from the public thoroughfare;

CONSIDERING THAT the alignment, orientation and height of the base of the first floor of the expanded building are in keeping with the layout generally observed in historic areas;

CONSIDERING THAT the shape, slope and materials of the roofs of the extension are similar to those of the original building;

CONSIDERING THAT the extended portion of the main building is not visible from the public road.

WHEREAS the Legault government has announced a budget of 4.9 million dollars to vitalize the living environment of seniors;

WHEREAS the "Clubs des 50 ans et plus" are located on the territory of Bas-Saint-Laurent-Gaspésie-Îles de la Madeleine, therefore in the so-called remote regions and often in devitalized municipalities;

- **THAT** the Council of the Town of Métis-sur-Mer supports the Clubs des 50 ans et plus de La Mitis in their request to be recognized as an organization that helps seniors;

- TO make a request for support to Mr. Pascal Bérubé;

- **TO** send a request to the Minister responsible for seniors, Mrs. Marguerite Blais, so that the "Clubs des 50 ans et plus" can benefit from the government assistance granted to vitalize the living environments of seniors.

10.3 Purchase of a Gazebo for the belvedere on rue Beach Street

RESOLUTION #22-06-100 PURCHASE OF A GAZEBO FOR THE LOOKOUT ON RUE BEACH

CONSIDERING THAT the Town received two bids and Cabanons DONADO & Rénovation DD is the less expensive,

It is proposed by Councillor Ms. Tracy Sim and unanimously resolved that the Council of the Town of Métis-sur-Mer award the contract for the purchase of an 8-sided Gazebo in treated wood 10' x 10' to Cabanons DONADO & Rénovation DD for an amount of \$7,500 plus taxes. This amount will be taken from the amount reserved for the CLD project that was not realized by the organization.
