#### RESOLUTION #23-04-58 ACCOUNTS PAYABLE

It is proposed by Councillor Mr. Simon Brochu and unanimously resolved that the Council of the Town of Métis-sur-Mer pays the invoice for the street furniture in the amount of \$4,662.94 plus taxes from the unreserved accumulated surplus.

It is proposed by Councillor Ms. Tracy Sim and unanimously resolved that the Council of the Town of Métissur-Mer supports the request of the organization Construction Métis to the MRC de La Mitis for the setting up, pre-start-up, canvassing and marketing of the Métis-sur-Mer eco-district.

#### **RESOLUTION #23-04-63**

#### DENOUNCE THE POOR CONDITION OF ROUTE 132 AT THE MTQ CROSSING THE TERRITORY OF MÉTIS-SUR-MER

CONSIDERING THAT Route 132, in its portion located on the territory of the Town of Métis-sur-Mer is in a pitiful state, namely that there are a multitude of potholes and cracks, not to mention that the road is extremely bumpy

CONSIDERING THAT the poor quality of Route 132 puts the safety of users at risk;

**CONSIDERING THAT** Route 132 is the only road leading to the gaspésie and that it is intolerable to have a road in such a state:

FOR THESE REASONS, it is proposed by Councillor Mr. Raynald Banville and unanimously resolved to ask the Ministre des Transports to proceed with the repair of Route 132 on the territory of the Town of Métis-sur-Mer as soon as possible.

7.3 Mandate Agua Ingénium to prepare the documents for the paving of MacNider road.

#### **RESOLUTION #23-04-64**

#### MANDATE AQUA INGÉNIUM TO PREPARE THE DOCUMENTS FOR THE PAVING OF **MACNIDER ROAD**

It is proposed by Councillor Mr. Simon Brochu and unanimously resolved that the Council of the Town of Métis-sur-Mer mandates the firm Aqua Ingénium to carry out the design and supervision of the road repair project on route MacNider at a cost of \$14,880 plus applicable taxes. This amount is budgeted in the Town's 2023 operating activities.

7.4 To mandate Goulet & Lebel Architects for the preparation of the preliminary study for the construction of the new municipal garage.

#### TO MANDATE GOULET & LEBEL ARCHITECTS TO PREPARE THE PRELIMINARY STUDY FOR THE CONSTRUCTION OF THE NEW MUNICIPAL GARAGE

It is proposed by Councillor Mr. Raynald Banville and unanimously resolved that the Council of the Town of Métis-sur-Mer mandates the architectural firm of Goulet & Lebel Architects to carry out the preliminary study for the construction of the new municipal garage at a cost of \$17,700 plus applicable taxes. This amount is subsidized in part by the PRACIM grant program.

8.1 Designation of Urbanism Inspectors concerning the intermunicipal agreement for the application of urbanism bylaws

#### **RESOLUTION #23-04-66**

DESIGNATION OF URBANISM INSPECTORS CONCERNING THE INTERMUNICIPAL AGREEMENT FOR THE APPLICATION OF URBANISM BY-LAWS

**CONSIDERING THAT** the municipality must appoint a person or persons responsible for the application of the planning bylaws and any other bylaws that it is responsible for applying and that it must appoint a person or persons responsible for issuing permits and certificates;

**CONSIDERING THAT** the municipality calls upon the personnel of the Regional Inspection Service of the MRC of La Mitis;

**CONSIDERING THAT** the municipality adopted, on November 30, 2015, an intermunicipal agreement for the application of urban planning bylaws linking it to the MRC de La Mitis;

**CONSIDERING THAT** the absence of the urban planning inspector assigned to the municipality may require his replacement, on an interim basis, by another inspector of the Department.

**FOR THESE REASONS,** it is proposed by Councillor Ms. Tracy Sim and unanimously resolved by the Municipal Council of Métis-sur-Mer to :

ALSO AUTHORIZES such persons to issue permits, notices of violation, demand letters and statements of offence for and on behalf of the Municipality.

8.2 Minor variances requested for two lots: lots n° 5 934 550 and 5,934,553 on rue Principale.

#### **RESOLUTION #23-04-67**

## MINOR VARIANCES REQUESTED FOR TWO LOTS: LOTS N° 5 934 550 AND 5,934,553 ON RUE PRINCIPALE

The purpose of this request is to authorize, in accordance with sections 10.4 and 10.10 of the *Zoning By-law*, the construction of an access to the lot and an off-street parking area at 0 metre from the lateral line of a lot, contrary to the by-law which provides for a minimum distance of 0.5 metre between an access to the lot, an off-street parking area and a lateral line of a lot.

Considering that the request respects the objectives of the urban plan;

**Considering that** the authorization of such a minor derogation request does not affect the enjoyment of property rights by the owners of neighbouring buildings;

**Considering the** authorization of such a request for minor derogation is not contrary to the Urbanism development Act;

**Considering that** the proposed development of the land and constructions allows the conservation of the existing access road as well as the natural characteristics in place, vegetation, slope of the slope;

**Considering** the applicant has submitted a geotechnical expertise as required by the zoning bylaw demonstrating that the whole of the interventions will not lead to a landslide in the short or long term which could affect the safety of people and property;

**Considering** the request pertains to a provision of the *Zoning By-law* which may be the object of a minor derogation.

#### FOR THESE REASONS.

It is moved by Councillor Mr. Raynald Banville and unanimously resolved that the Council of the Town of Métis-sur-Mer accepts the recommendation of the members of the Planning Advisory Committee and grants the request for a minor exemption as requested and specified in the public notice

8.3 To request the Government of Quebec to intervene with the Government of Canada to ensure the insurance of heritage buildings at reasonable costs.

#### **RESOLUTION #23-04-68**

ASK THE GOVERNMENT OF QUEBEC TO INTERVENE WITH THE
GOVERNMENT OF CANADA TO ENSURE THE INSURANCE OF HERITAGE BUILDINGS AT
REASONABLE COSTS.

**WHEREAS** the considerable efforts recently undertaken by the Government of Quebec and the municipalities on the legal and financial levels to promote better preservation and restoration of Quebec's built heritage;

**WHEREAS** the support program for municipal real estate heritage undeniably contributes to the social acceptability of new regulatory constraints that are highly beneficial to the preservation of this heritage;

WHEREAS the major impact of a denial of insurability for owners of older properties;

**WHEREAS,** the actions of insurers contribute to discouraging owners of old properties from preserving them and potential new buyers from acquiring them and, consequently, contribute to the devaluation of said heritage, jeopardizing its preservation;

**WHEREAS** the actions of the insurers compromise those related to the new orientations of the government and the municipalities for the implementation of tools for the identification and management of this heritage.

### IT IS PROPOSED BY COUNCILLOR MR. SIMON BROCHU AND UNANIMOUSLY RESOLVED BY THE MEMBERS PRESENT

**THAT** the preamble is an integral part of this resolution;

**THAT** the Town of Métis-sur-Mer request the Government of Quebec to intervene with the Government of Canada and the competent authorities to quickly find solutions to guarantee, at reasonable cost, the insurability of all heritage buildings, regardless of the age of the building or a component, the identification of the building in an inventory, its status, its location in the zoning or its submission to regulations aimed at preserving its characteristics;

**TO** ask all the MRCs and municipalities of Quebec as well as those involved in the protection of Quebec's heritage to join their voices by adopting this resolution;

**TO** forward this resolution to the Government of Quebec, the Ministère de la Culture et des Communications, the Ministère des Affaires municipales et de l'Habitation, the federal and provincial Members of Parliament of the territory, the municipalities and MRCs of Quebec, the Fédération québécoise des municipalités, the Union des municipalités du Québec Friends and Owners of Quebec's Older Houses (APMAQ), Action Patrimoine, Héritage Montréal, the Ordre des urbanistes du Québec, the Ordre des architectes du Québec, the Insurance Bureau of Canada, the Regroupement des cabinets de courtage d'assurance du Québec (RCCAQ), and Gérard Beaudet, professor at the Université de Montréal and Jean-François Nadeau, journalist at Le Devoir.
