RESOLUTION #23-06-101 MUTUAL AID AGREEMENT ON FIRE SAFETY WITH THE MATAPEDIA MRC

It is proposed by Councillor Tracy Sim and unanimously resolved that the Council of the Town of Métis-sur-Mer appoint the Mayor and the Director General of the Town of Métis-sur-Mer as signatories to the mutual aid agreement on fire safety between the MRC de la Matapédia and the Town of Métis-sur-Mer.

RESOLUTION #23-06-102 RESOLUTION OF INTENT TO JOIN THE FIRE DEPARTMENT

CONSIDERING THAT the Town of Métis-sur-Mer and the municipalities of Price, Sainte-Angèlede-Mérici, Saint-Octave-de-Métis, Grand-Métis, Padoue and Sainte-Jeanne-d'arc are joining forces within the framework of the Mitis-Est fire group project;

WHEREAS the sharing of resources and expertise will promote better fire and civil protection coverage and confer numerous advantages in terms of governance and administration;

WHEREAS in 2023, the Municipality of Sainte-Angèle-de-Mérici joined the group, while the Town of Métis-sur-Mer will join in 2024;

WHEREAS the group wishes to enter into an intermunicipal fire grouping agreement for a term of 15 years, renewable every 5 years;

WHEREAS the creation of an intermunicipal board would formalize the Mitis-Est fire grouping project;

IT IS THEREFORE PROPOSED by Councillor Raynald Banville and unanimously resolved by the members of the Council of the Town of Métis-sur-Mer to signify its intention to adhere to the steps aimed at the constitution of an intermunicipal board in the Mitis-Est sector relative to the organization of the fire and civil security service.

RESOLUTION #23-06-103

PROJECT SUBMITTED TO THE PROGRAMME D'AMÉLIORATION ET DE CONSTRUCTION D'INFRASTRUCTURES MUNICIPALES (PRACIM) - VILLAGE DE PRICE FIRE HALL

WHEREAS the Town of Métis-sur-Mer and the municipalities of Price, Sainte-Angèle-de-Mérici, Saint-Octave-de-Métis, Grand-Métis, Padoue and Sainte-Jeanne-d'arc are joining forces to build a new fire station to serve the Mitis-Est fire department as part of a project submitted to the Programme d'amélioration et de construction d'infrastructures municipales (PRACIM).

Consequently, it is proposed by Councillor Alexandre Tanguay and unanimously resolved by the members of the Council of the Town of Métis-sur-Mer that :

- The municipal council authorizes the application for financial assistance;
- The Municipality has read the PRACIM guide and undertakes to comply with all the conditions that apply to it;

- The Municipality undertakes, if it obtains financial assistance for its project, to pay its share of eligible costs as well as the ongoing operating and maintenance costs of the subsidized building;
- The Municipality confirms that, if it obtains financial assistance for its project, it will assume all costs not eligible for PRACIM associated with its project, including any cost overruns.
